According to the Board of ELEKTROTIM S.A. the value of achieved orders and the portfolio of orders will have or may have an influence on the results of the current and future quarters of the Company and the ELEKTROTIM Group of Companies:

ELEKTROTIM S.A. in the period from 01.10.2013 to 30.09.2014 won orders of the value of PLN 206,564,000 net.

ELEKTROTIM S.A. in the period from 01.10.2012 to 30.09.2013 won orders of the value of PLN 123,128,000 net.

The dynamics of the value of won orders in the period from 01.10.2013 to 30.09.2014 in comparison to the period from 01.10.2012 to 30.09.2013 is 168%.

ELEKTROTIM S.A. in the period from 01.10.2013 to 30.09.2014 submitted approx. 1,260 offers of the value of approx. PLN 1.5 billion net and won 195 orders of the value of PLN 206,564,000 net.

ELEKTROTIM S.A. in the period from 01.10.2012 to 30.09.2013 submitted approx. 1.164 offers of the value of approx. PLN 1.2 billion net and won 180 orders of the value of PLN 123,128,000 net.

The dynamics of the submitted orders in the period from 01.10.2013 to 30.09.2014 in comparison to the submitted orders in the period from 01.10.2012 to 30.09.2013 is 108%.
