The Management Board of ELEKTROTIM S.A. acting on the basis of Article 70, subsection 3 of the Act of 29 July 2005 on Public Offering, on Conditions for the Introduction of Financial Instruments to the Organized Trading System and on Public Companies, publishes the list of Shareholders holding at least 5% of votes at the Ordinary General Meeting of Shareholders of ELEKTROTIM S.A. which was held on 7 June 2016.

Krzysztof Folta: 1,504,364 shares/votes (24.37% of votes at the Ordinary General Meeting of Shareholders; 15.06% share in the total number of votes), Ewa and Krzysztof Folta at GMS of ELEKTROTIM S.A. jointly held: 1,904,364 shares/votes (30.85% of votes at the Ordinary General Meeting of Shareholders; 19.07% share in the total number of votes),
2. AVIVA Otwarty Fundusz Emerytalny AVIVA BZ WBK: 979,000 shares/votes (15.86% of votes at the Ordinary General Meeting of Shareholders; 9.8% share in the total number of votes),
3. Krzysztof Wieczorkowski: 820,000 shares/votes (13.28% of votes at the Ordinary General Meeting of Shareholders; 8.21% share in the total number of votes),
4. Mirosław Nowakowski: 607,000 shares/votes (9.83% of votes at the Ordinary General Meeting of Shareholders; 6.08% share in the total number of votes),
5. Nationale-Nederlanden Otwarty Fundusz Emerytalny: 580,000 shares/votes (9.39% of votes at the Ordinary General Meeting of Shareholders; 5.8% share in the total number of votes),
6. Jan Walulik: 380,000 shares/votes (6.15% of votes at the Ordinary General Meeting of Shareholders; 3.8% share in the total number of votes),
